#### Methods for cleaning up

Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Approach the spillage from upwind. Avoid generation and spreading of dust. Small Spillages: Remove spillage with vacuum cleaner or collect with a shovel and broom, or similar. Large Spillages: Collect spillage with a shovel and broom, or similar and reuse, if possible. Collect and place in suitable waste disposal containers and seal securely.
